ADVOCACY



Hosted the 4th annual DC Pet Care Community Fly-In, virtually connecting the pet care community with nearly 100 federal lawmakers to advocate for enhancing opportunities to experience the human-animal bond, protecting animal and human health, and more.

Monitored over 1,500 pet-related government proposals, engaging on those that could be harmful—or beneficial—to pet well-being and pet businesses. Supported enacted legislation including:

- PAWS for Veterans Therapy Act increasing opportunities for service animals
- Enhanced animal care regulations for shelters and rescues
- Elimination of pet ownership restrictions

RESPONSIBILITY



Established a Canine Care Committee to share information, improve practices and inform policy to promote and protect the health and well-being of dogs in the pet trade throughout their journey to becoming beloved family pets.

Continued to advocate for reopening the sustainable Hawaiian aquarium fishery by submitting and validating a West Hawaii Environmental Impact Statement (EIS) that was accepted by the state, and by defending the fishery in multiple court cases.

COLLABORATION

Worked with the U.S. Fish and Wildlife Service and other state and federal agencies to develop and provide guidance to pet businesses to impede the spread of Zebra mussels—one of the most ecologically and economically disruptive invasive species in North America—after they were discovered in aquatic moss ball products in multiple states.

Joined with more than 20 organizations from around the world to re-establish the International Pet Advisory Council for international communication and cooperation on pet care issues.

Working with a broad coalition of transport, retail and manufacturing associations on the Ocean Shipping Reform Act of 2021 (H.R. 4996) to end supply chain disruptions that are crippling pet businesses.

Collaborating with the University of Tennessee Institute of Agriculture and partners on a pilot scientific study of amphibians to improve animal wellbeing by developing solutions to mitigate harmful microbes, optimize beneficial microbes and decrease opportunities for spillover from captive to wild populations.
