

Amends Article II (Tax for Education), Part III (Exclusions from Tax) of PA Tax Reform Code of 1971 to exclude from the imposition of sales tax the sale at retail or use of food that is purchased exclusively for household pets. For purposes of this section: "Household pet" means a fully domesticated animal owned for personal companionship, including a dog, cat, reptile, bird or rodent.

Amends Title 18 (Crimes & Offenses), Chapter 55 (Riot, Disorderly Conduct & Related Offenses), Subchapter B (Cruelty to Animals), Section 5533 (Cruelty to Animal) of PA Consolidated Statutes to include ear cropping or ear trimming in the offense of animal cruelty. Provides that a violation of Section 5533 is a summary offense if the violation causes bodily injury to the animal due to the cropping, trimming or cutting off the whole or part of the ear or ears of the animal by a person who is not a licensed doctor of veterinary medicine or who is not acting in accordance with section 5542(a) (relating to animal mutilation and related offenses). Provides that a violation of this section is as follows: (i) A misdemeanor of the second degree for the first violation; and ii) A misdemeanor of the first degree for a second or subsequent violation.

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in riot, disorderly conduct and related offenses, providing for the offense of kidnapping of animals.

Amends Title 18 (Crimes & Offense), Article F (Offenses Against Public Order & Decency), Chapter 55 (Riot, Disorderly Conduct & Related Offenses), Subchapter B (Cruelty to Animals) of PA Consolidated Statutes by adding a new Section 5539.1 providing for the offense of kidnapping of animals. Provides that a person commits an offense of kidnapping of animals if the person: 1) Intentionally, knowingly or recklessly takes, sells or purchases any dog, cat, equine animal, swine or cattle for resale to another, use in a laboratory or for animal fighting; or 2) Intentionally, knowingly or recklessly takes or carries away any dog, cat or equine animal without permission for a special or temporary purpose. Provides that an offense under subsection 1) is a felony of the third degree and a second or subsequent offense is a felony of the second degree. Provides that an offense under subsection 2) is a misdemeanor of the third degree and a second or subsequent offense is a misdemeanor of the second degree.

Amends Title 18 (Crimes and Offenses), Article F (Offenses Against Public Order and Decency), Chapter 55 (Riot, Disorderly Conduct & Related Offenses), Subchapter B (Cruelty to Animals), Section 2242 (Animal Mutiliation & Related Offenses) of PA Consolidated Statutes by adding a new subsection to add declawing of cats to the offense of cruelty to animals. Provides that a person commits an animal cruelty offense if the person performs an onychectomy, a declawing, partial digital amputation, phalangectomy or tendonectomy procedure by any means unless the procedure is deemed necessary for a therapeutic purpose by a licensed doctor of veterinary medicine. For purposes of this section: "Therapeutic purpose" means a purpose necessary to address the physical medical condition of the cat, such as an existing or recurring physical illness, infection, disease, injury or abnormal condition in a claw that compromises the cat's health. The term does not mean cosmetic or aesthetic reasons or reasons of convenience in keeping or handling the cat.

An Act to amend Section 459-207 (Requirements for Kennels) of the PA Dog Law by adding a new subsection to further provide for the display of breeder information by pet shop-kennels. Provides that a dog offered for sale by a pet shop-kennel shall have the following information posted conspicuously on its cage: 1) The breed, age and date of birth of the dog; 2) The state in which the breeder of the dog is located; 3) The United States Department of Agriculture License number of the breeder, if required; 4) The Pennsylvania Department of Agriculture License number of the breeder, if required; and 5) Documentation of all inoculations, worming treatments and other medical treatments, if any, including the date of the medical treatment, the diagnosis and the name and title of the treatment provider. Provides that a dog offered for sale or adoption on behalf of a licensed nonprofit kennel by a pet shop-kennel shall also have the above-mentioned information in posted conspicuously on its cage to the extent the information is known.

Amends Title 18 (Crimes & Offenses), Chapter 55 (Riot, Disorderly Conduct and Related Offenses), Subchapter B. (Cruelty to Animals), Section 5555 (Prohibition of Ownership) of PA Consolidated Statutes to further provide for the prohibition of pet ownership for persons convicted of animal cruelty violations. Provides that the authority imposing sentence upon a conviction for a violation of this chapter SHALL (currently "may") order the prohibition of the defendant's ownership, possession, control or custody of animals or employment with the care of animals for a period of NO LESS THAN 2 YEARS (currently "time not to exceed the statutory maximum term of imprisonment applicable to the offense for which sentence is being imposed"). Provides for mandatory violence prevention counseling (failure to attend extends period of pet ownership prohibition from 1-10 years.

An Act amending the act of December 7, 1982 (P.L.784, No.225), known as the Dog Law, in licenses, tags and kennels, further providing for requirements for kennels; and abrogating a regulation.

Amends Section 207 (Requirements for Kennels) of PA Dog Law to apply the primary enclosure and housing facilities requirements currently in statute for Kennel Class C license holders to all kennels. Provides that the existing Kennel Class C primary enclosure design, construction, and sanitation requirements shall apply to ALL kennels. Adds provision that the relative humidity in a housing facility must be maintained at a level that accomplishes a Heat Index value of 85 or lower. Strikes the following requirements (currently in statute for Kennel Class C license holders: (1) Kennels under this subsection must develop and follow an appropriate plan to provide dogs with the opportunity for exercise. The plan shall be approved by a veterinarian. (2) All kennels for dogs shall be equipped with smoke alarms or fire extinguishers. Housing facilities shall be equipped with fire extinguishers on the premises. An indoor housing facility may have a sprinkler system. For purposes of this section: "Kennel" means any establishment in or through which at least 26 dogs are kept or transferred in a calendar year, or a boarding kennel as defined in this act. "Kennel Class C License Holder" means to keep or operate a commercial kennel for a total number of dogs ranging from 50 to more than 500 dogs of any age during a calendar year.

An Act amending Title 34 (Game) of the Pennsylvania Consolidated Statutes, in permits relating to wildlife, further providing for definitions.

Amends Title 34 (Game), Subchapter D (Permits Relating to Wildlife), Section 2961 (Definitions) of PA Consolidated Statutes to exclude birds, rats and mice, rabbits, hedgehogs, sugar gliders and domestic ferrets from the definition of "exotic wildlife". Amends the definition of "exotic wildlife" to INCLUDE: ALL nonindigenous animals AND the following, regardless of whether the animal is bred or reared in captivity or imported from another state or nation: 1) All members of the order Primates (nonhuman primates); 2) All members of the family Ursidae (bears); 3) Members of the following species: a) Canis latrans (coyotes); b) Canis lupus (gray wolves); c) Canis rufus (red wolves); d) Felis rufus (bobcats); e) Panthera leo (lions); f) Panthera tigris (tigers); g) Panthera pardus (leopards); h) Panthera uncia (snow leopards); i) Neofelis nebulosa (clouded leopards); j) Panthera onca (jaguars); k) Acinonyx jubatus (cheetahs); I) Felis concolor (cougars). 4) Any crossbreed of an animal specified in subparagraph 3 which have similar characteristics in appearance or features. "Exotic wildlife" DOES NOT include: 1) Any member of the class Aves (birds); 2) Any member of the following families: a) Equidae (horses, asses and zebras); b) Camelidae (camels, alpacas and llamas); c) Cervidae (deer, moose and elk); d) Bovidae (wild cattle and spiral-horned antelopes); e) Muridae (rats and mice); f) Chinchillidae (chinchillas and viscachas); g) Leporidae (rabbits and hares); h) Erinaceidae (hedgehogs and moonrats); i) Petauridae (gliders and striped possums) 3) Any member of the species Mustela furo (domestic ferrets). 4) Any member of the species Cavia porcellus (domestic guinea pigs). 5) Any domestic animal, as defined in 18 Pa.C.S. §5531 (a dog, cat, equine animal, bovine animal, sheep, goat or porcine animal). Current definition of "Exotic wildlife": The phrase includes, but is not limited to, all bears, coyotes, lions, tigers, leopards, jaguars, cheetahs, cougars, wolves and any crossbreed of these animals which have similar characteristics in appearance or features. The definition is applicable whether or not the birds or animals were bred or reared in captivity or imported from another state or nation.

Amends Title 40 (Insurance), Part II (Regulation of Insurers and Related Persons Generally) of PA Consolidated Statutes by adding a new Chapter 45 (Pet Insurance) to provide for the regulation of pet insurance. Provides for: (1) The right to examine and return an insurance policy; (2) Written policy disclosure requirements; (3) Policy conditions (pre-existing conditions, waiting periods, veterinary examinations, wellness program benefits; (4) Sales practices requirements; (5) Insurance producer training; and (6) penalties and remedies. Provides that the Insurance Commissioner of the Commonwealth may promulgate rules and regulations to administer and enforce this chapter. For purposes of this section: "Pet insurance policy" means a property insurance policy, certificate or rider that provides coverage for accidents and illnesses of pets. "Pet insurer" means an insurer that issues a pet insurance policy.

Amends Title 3 (Agriculture), Chapter 8 (Dog Law), Sections 459.102 (Definitions) and 459.206 (Kennels) of PA Consolidated Statutes to prohibit the retail sale of dogs by pet shops. Provides that the PA Department of Agriculture may not issue or renew a pet shop-kennel license after December 31, 2024. Provides that, as of January 1, 2025, a person who held a pet shop-kennel license: (1) Shall immediately cease and desist from operating a kennel, including buying, exchanging, selling, offering for sale, giving away or in any way transferring dogs; (2) May not acquire additional dogs or increase the number of dogs in the kennel by any means, including breeding; and (3) Must permit State dog wardens to inspect the kennel without a warrant in order to determine compliance with the department's order, any relevant court order and any provision of this act. Amends definition of "dealer kennel" to provide that the term DOES NOT include a "pet shop-kennel". Strikes references to "pet shop-kennel" from kennel licensing provisions in current statute. For purposes of this section: "Pet shop-kennel" means any kennel or person that acquires and sells dogs for the purpose of resale, whether as owner, agent or consignee, and sells or offers to sell such dogs on a retail basis.

Amends Title 3 (Agriculture), Chapter 8 (Dog Law), Sections 459.102 (Definitions), 459-502-A (Registration) and 459-503-A (Requirements) of PA Consolidated Statutes to: (1) Add a definition for "unprovoked"; and (2) Further provide for court proceedings, certificate of registration and disposition. Adds a definition for "unprovoked" to mean action by a dog that includes biting, attacking or forcibly coming into unwanted physical contact with a person or domestic animal that is acting peaceably and lawfully. Adds to the summary offense of harboring a dangerous dog if a dog has done any of the following unprovoked: (1) Attacked a human being on public or private property not owned, controlled or used with permission by the owner of the dog; (2) Inflicted severe injury on a human being on private property owned, controlled or used with permission by the owner of the dog; (3) Killed or inflicted severe injury on a domestic animal, dog or cat while on public or private property not owned, controlled or used with permission by the owner of the dog; or (4) Attacked a domestic animal, dog or cat, whether or not an injury occurred, and the dog has a history of attacking human beings or domestic animals, dogs or cats unprovoked. Increases the fee to obtain a dangerous dog certificate from \$500 to \$1,000 per calendar year.

Amends Title 3 (Agriculture), Chapter 8 (PA Dog Law), Section 217 (Service dogs and dogs used by municipal or State Police departments) of PA Consolidated Statutes to add detection dogs to the provisions of the section. Includes detection dogs in the fee and licensing exemption already provided for service dogs used by municipal or State Police departments. For purposes of this section: "Detection dog" means a dog which is trained and used for accelerant detection, bomb or explosives detection, narcotics detection or other scent detection. "Service dog" means any dog which has been or is in the process of being trained as a guide dog, signal dog or has been trained to do work or perform tasks for the benefit of an individual with a disability, including, but not limited to, guiding individuals with impaired vision, alerting individuals with impaired hearing to intruders or sounds, pulling a wheelchair or fetching dropped items.

Amends the PA Tax Reform Code of 1971 by adding a new XVIII-I to provide for a shelter animal adoption tax credit. Provides that a taxpayer may claim a tax credit of \$100 per adopted shelter animal. Provides that a taxpayer may claim a tax credit for a maximum of 3 shelter animals per taxable year, provided that keeping the shelter animal is not in violation of any applicable provisions of Federal, State or local law. For purposes of this section: "Shelter animal" means cat or dog placed in a pound, shelter, society for the prevention of cruelty to animals, humane society or rescue association.

Amends Title 3 (Agriculture), Chapter 3 (Domestic Animals), Subchapter C. (Detection, Containment or Eradication of Certain Diseases) of PA Consolidated Statutes by adding a new Section 2336 to require certain retailers to post notices with information on dangerous transmissible diseases. Provides that the Department of Agriculture may require a dealer, agent or person that offers a domestic animal, commercial feed or pet food for sale to the public to provide a posted notice on the premises with information on a dangerous transmissible disease. For purposes of this section: "Dangerous transmissible disease" includes (among others diseases): (1) Pseudorabies, an infectious disease of swine, cattle, sheep, goats, dogs and cats caused by Herpesvirus suis; (2) Rabies, an infectious disease of cattle, dogs, cats, sheep, horses and man caused by a virus; (3) Salmonellosis, an infection of animals and man caused by various Salmonella species: S. pullorum (poultry), S. typhimurium (cattle, equine and man), S. dublin (cattle and man), S. gallinarum (poultry) and S. cholerasuis (swine).

Amends Title 23 (Domestic Relations), Section 3102 (Legislative Findings and Intent) of PA Consolidated Statutes by adding a new subsection to include companion animals in the division of marital property. Provides that, upon the request of either party, the court shall provide for the possession or care, or both, of a companion animal of the parties. Provides that parties may enter into an enforceable agreement regarding the possession or care, or both, of a companion animal. For purposes of this section: "Companion Animal" means an animal that: 1) is a domesticated, living being commonly referred to as a pet; or 2) has been bought, bred, raised or otherwise acquired in accordance with applicable law for the primary purpose of providing the owner with assistance in relation to a disability, security or companionship, rather than for business or agricultural purposes.

Amends Title 34 (Game), Sections 2961 (Definitions) and 2963 (Exotic Wildlife Possession Permits) of PA Consolidated Statutes by: 1) Redefining "exotic wildlife" and "exotic wildlife dealer"; and 2) Discontinuing the issuance of Exotic Wildlife Possession Permits. Redefines "Exotic Wildlife" to mean all nonindigenous animals and the following, regardless of whether the animals are bred or reared in captivity or imported from another nation or state: (1) All members of the order Primates (nonhuman primates); (2) All members of the family Ursidae (bears); (3) All members of the species: (i) Canis latrans (coyotes); (ii) Canis lupus (gray wolves); (iii) Canis rufus (red wolves); (iv) Felis rufus (bobcats).; (v) Panthera leo (lions); (vi) Panthera tigris (tigers); (vii) Panthera pardus (leopards); (viii) Panthera uncia (snow leopards); (ix) Neofelis nebulosa (clouded leopards); (x) Panthera onca (jaguars); (xi) Acinonyx jubatus (cheetahs); (xii) Felis concolor (cougars); and (xiii) Any crossbreed of the animals specified in this paragraph. (4) All members of the family Elephantidae (elephants). The term DOES NOT include any member of the class Aves (birds), any member of the families Equidae (horses, asses and zebras), Camelidae (camels, alpacas and llamas), Cervidae (deer, moose and elk), Bovidae (wild cattle and spiral-horned antelopes), Muridae (rats and mice), Chinchillidae (chinchillas and viscachas), Leporidae (rabbits and hares), Petauridae (gliders and striped possums) or any member of the species Mustela furo (domestic ferrets) or Cavia porcellus (domestic guinea pigs) or any domestic animal as that term is defined in 18 Pa.C.S. Ch. 55 Subch. B. (A dog, cat, equine animal, bovine animal, sheep, goat or porcine animal). Redefines "Exotic Wildlife Dealer" as any person who: (1) Imports into this Commonwealth, possesses, buys, sells, locates or finds for a fee, barters, donates, gives away or otherwise disposes of exotic wildlife; and (2) Engages in at least five documented transactions annually involving exotic wildlife Provides that the Commission shall not issue any new Exotic Wildlife Possession Permits and may only issue Exotic Wildlife Dealer Permits and Menagerie Permits (exempts wildlife sanctuaries).

The "Dog and Cat Protection Act" provides for certain dog dealer and dog kennel sourcing restrictions and includes owners and employees of dealers and kennels in the PA Whistleblower Law. Provides that a dealer or kennel may not import for sale, sell or offer for sale, including a sale for research purposes, a dog bred by a person who has received any of the following from the USDA as authorized under the Animal Welfare Act and its attendant regulations: (1) A citation for a direct or critical violation or citations for 3 or more indirect or noncritical violations during the 2-year period before the procurement of the dog. (2) 2 consecutive citations for no access to a housing facility before the procurement of the dog.
